- a) fireworks must be of consumer grade Type F.1;
- b) spotters must be used before and after fireworks;
- c) inspection of sight before and after fireworks are set off.
- d) fallout area should be free of spectators, vehicles, combustible materials and overhead objects.
- e) Experts say the minimum distance from the launch area to the spectators should be a radius of at least 70 feet per inch of the internal diameter of the largest mortar used. These are minimum distances; and may need to increase them due to site characteristics, weather conditions or other factors.
- f) the permitee shall hold the Town of Lanigan harmless of any liability.
